

## **Terms and Conditions**

1. Track Events are for participants to be able to improve their driving skills while in a closed course with safety in mind. The circuit is a racing course but ThEvent is for enjoyment and skill improvement only, not with top speed in mind. Racing with other participants is strictly forbidden.
2. **Conditions for all participants:**
  - a. All participants must have filled out the application form completely before entry to the circuit.
  - b. All participants' accounts need to be fully paid before entry to the circuit.
  - c. Payment must be received within 2 weeks for bookings done on line or the booking will be cancelled.
  - d. All participants must sign the waiver form before entry to the circuit.
  - e. All participants must attend the drivers' briefing before entry to the circuit.
  - f. All participants must have a valid European Drivers License. If the participant does not have a valid driver license please contact ThEvent.
  - g. All participants must own the car they are driving. If not they must have an agreement with the owner of the car to use it at ThEvent, this must be proven to the organizer (The Event A.G.) before entry to the circuit.
  - h. All participants must have all the appropriate wrist bands (supplied by the organizer The Event A.G.) on their wrists before entry to the circuit.
  - i. All cars must have a legal minimum liability insurance (of 1 million Euros).
  - j. The organizer (The Event A.G.) has the right to permit cars which are not certified for public roads, but the owners must provide proof of liability insurance for the car before ThEvent (even if it is only short term insurance).
  - k. All cars must be checked for safety before ThEvent.
  - l. The organizer (The Event A.G.) reserves the right to refuse entry of any participants without explanation.
3. **Insurance:**
  - a. All participants are not insured against any of the risks that are connected with ThEvent.
4. **Safety:**
  - a. All participants must use a seat belt and wear a protective helmet.
  - b. All participants must obey the staff of the organizer (The Event A.G.). If the participants fail to do so they will be excluded from ThEvent with no compensation given.
  - c. All passengers must also wear a seat belt and wear protective helmet and also must sign the waiver form supplied by the organizer (The Event A.G.) before entry to the circuit.
  - d. All participants must not be under the influence of alcohol before entry to the circuit.
  - e. No participants under the age of 14 are allowed on pit lane or the circuit. This also includes being a passenger in a car.
  - f. All cars must have the tow hook installed and a working fire extinguisher
5. **Identification of the Cars:**
  - a. All participants will be given numbers by the organizers (The Event A.G) that must be placed on the cars before entry to the circuit.

- b. All participants will be given by the organizers (The Event A.G.) group stickers that must be placed on the windscreen of the cars before entry to the circuit.

**6. Cancellation:**

- a. If the participant cancels more than 60 days before ThEvent they will receive full refund minus 50 Euro for office fees.
- b. If the participant cancels between 60 and 30 days before ThEvent they will receive half of his payment minus 50 Euro for office fees.
- c. If the participant cancels less than 30 days before The Event they will receive no compensation.
- d. If for any reason the organizer (The Event A.G.) needs to cancel ThEvent there will be no refund or compensation given to the participants.

**Non-Liability:**

The organizer (The Event A.G.) and all people associated with them will not be liable for any damages to the circuit, its facilities, the participant, the passenger, the participant's guest(s), or the participant's car(s).

All participants who signed the entry form and waivers agree to participate in ThEvent knowing that they carry alone the civilian and criminal responsibility for all the danger involved in ThEvent or that of the damage that can be caused by the cars.

The participant who signed, agree that all beneficiaries to him must also abide to his agreement to being liable for all damages he may cause, ensuring that the organizer (The Event A.G.) is not liable. The participant who signed the agreement recognizes that the organizer (The Event A.G.) is not liable for any damages that the participant may cause or incur during ThEvent. Therefore all damages caused by the participant must be paid in full by the participant or his insurance company and may not come from the organizer (The Event A.G.) in anyway including the registration money that was given for ThEvent.

**TRANSPORT:**

Open trailer transport. The organiser (The Event A.G.) reserves the right to move your car from an open trailer to a closed trailer due to logistical spacing. The customer will be notified as soon as possible if this is necessary and what the cost difference will be.

**COPYRIGHT RESTRICTIONS:**

The organiser (The Event A.G.) reserves the right to make use of any and all acquired audio-visual material during any of its organised events for its own business or promotional use, as well as for distribution to third parties, including media.

No participants will be permitted to use any audio/visual material for purposes other than for private or personal use

**Data Protection:**

All the participant data that is supplied to the organizer (The Event A.G.) is for registration purpose. This information will then be stored and used only as a customer data base for the company The Event A.G.
